## ORDER

This matter comes before the Court on various motions now pending before the Court. These motions are resolved as follows.

- 1. The Roman Catholic Church of the Archdiocese of New Orleans' Motion to Shorten Time to Respond to Interrogatories (Doc. #266) is **DENIED as moot**.
- 2. Certain investors filed The Investors' Motion to Direct Receiver to Consent to Investors' Transfer of Their Limited Partnership Interests In Founding Partners Stable-Value Fund, L.P. and Founding Partners Stable-Value Fund II, L.P. (Doc. #309). The Receiver filed a Response in Opposition (Doc. #312). The Non-Party Investors also filed a Request for Oral Argument (Doc. #320). The

Receiver filed a Response in Opposition to The Moving Investors' Request for Oral Argument (Doc. #326). After full consideration of the matter, the motion and request for oral argument are **DENIED**.

- 3. The Receiver filed an Application for Payment of Fees and Expenses Incurred by the Receiver, Retained Counsel, and Other Professionals in the Above-Styled Proceeding (Doc. #313), along with a Notice of Filing Additional Pages (Doc. #314). Edge Capital Investments, Ltd. filed an Objection (Doc. #316), and Cross Motion to Direct the Receiver to Disclose Claim Information, Set a Briefing Schedule for any Unresolved Issues Relating to the Claims Process and Direct Appointment of Evatt Tamine to the FP Designee Board (Doc. #317). Edge Capital Investments, Ltd. also filed a Notice of Filing Declarations (Doc. #321). The Receiver filed a Response in Opposition to Edge Capital Investments Ltd.'s Objections and Cross Motions (Doc. #324). Defendants filed a Statement of Position Regarding Investor Submissions on the Settlement Process (Doc. #327). Edge Capital filed a Reply Brief (Doc. #332), to which the Receiver filed a Sur-Reply (Doc. #334). The objection is **OVERRULED** and the cross motion is **DENIED**.
- 4. The Receiver's Motion for Entry of an Order Authorizing Agreement with Specialty Finance Partners, LLC (Doc. #338) is GRANTED without objection.

Accordingly, it is now

## ORDERED:

- 1. The Roman Catholic Church of the Archdiocese of New Orleans' Motion to Shorten Time to Respond to Interrogatories (Doc. #266) is **DENIED as moot**.
- 2. The Investors' Motion to Direct Receiver to Consent to Investors' Transfer of Their Limited Partnership Interests In Founding Partners Stable-Value Fund, L.P. and Founding Partners Stable-Value Fund II, L.P. (Doc. #309) is **DENIED**.
- 3. The Non-Party Investors' Request for Oral Argument (Doc. #320) is **DENIED**.
- 4. The Receiver's Application for Payment of Fees and Expenses Incurred by the Receiver, Retained Counsel, and Other Professionals in the Above-Styled Proceeding (Doc. #313) is **GRANTED** for the amounts stated on page 12 of the application.
- 5. Edge Capital Investments, Ltd.'s Objection (Doc. #316) is OVERRULED, and its Cross Motion to Direct the Receiver to Disclose Claim Information, Set a Briefing Schedule for any Unresolved Issues Relating to the Claims Process and Direct Appointment of Evatt Tamine to the FP Designee Board (Doc. #317) is DENIED.
- 6. The Receiver's Motion for Entry of an Order Authorizing Agreement with Specialty Finance Partners, LLC (Doc. #338) is GRANTED. The Receiver may enter into the Specialty Finance
